## **Approval of Minutes**

### **Election of Chair and Co-Chair for 2021-2022**

Sen. Kiffmeyer opened nominations for the Legislative Budget Office Oversight Commission chair. Rep. Albright nominated Rep. Hertaus. Sen. Marty nominated Rep. Noor. Sen. Kiffmeyer called for a vote and Rep. Hertaus received four votes (Hertaus, Kiffmeyer, Rosen, Albright) and Noor received three votes (Noor, Wiklund, Marty). Rep. Elkins had not yet joined the meeting when the vote was taken.

Sen. Kiffmeyer turned the gavel over to the new chair, Rep. Hertaus. Rep. Hertaus opened the nominations for Vice Chair. Sen. Rosen nominated Sen. Kiffmeyer. Rep. Noor nominated Sen. Wiklund. Sen. Kiffmeyer withdrew her name from consideration as vice chair, and moved to unanimously elect Sen. Wiklund as vice chair.

The commission discussed the custom and practice of commissions concerning electing officers, reconsidering a vote, and the bylaws of this commission.

Rep. Elkins moved to reconsider the vote of the commission chair.

After further discussion, Sen. Kiffmeyer moved to recess the meeting. Chair Hertaus recessed the meeting at 11:26, to reconvene at 11:35 a.m.

The meeting reconvened at 11:35 a.m. Chair Hertaus took up the motion to reconsider the vote of the commission chair. THE MOTION FAILED.

Chair Hertaus turned to the nominations for vice chair. Sen. Kiffmeyer moved to unanimously elect Sen. Wiklund as vice chair.

After further discussion, Sen. Wiklund withdrew her name from consideration.

Rep. Noor moved to adjourn the meeting. Sen. Marty asked for a division vote. The vote to adjourn was:
